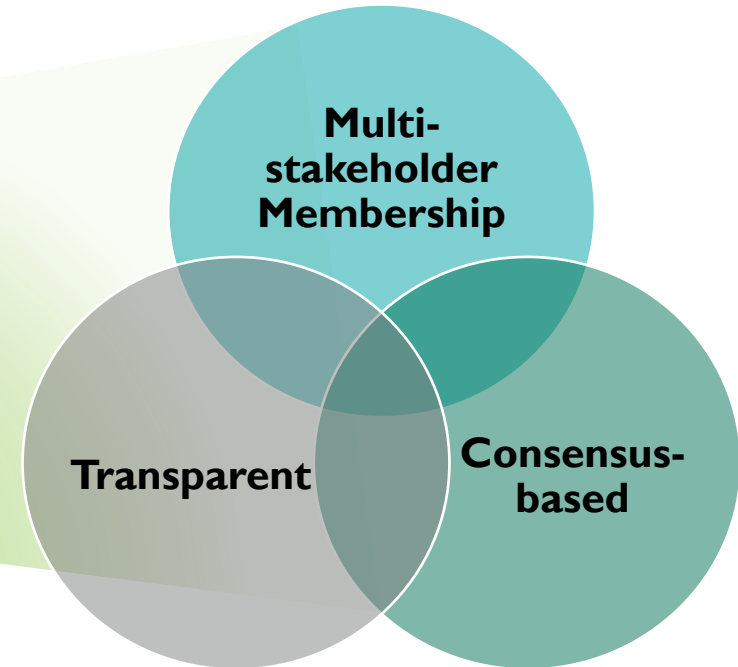


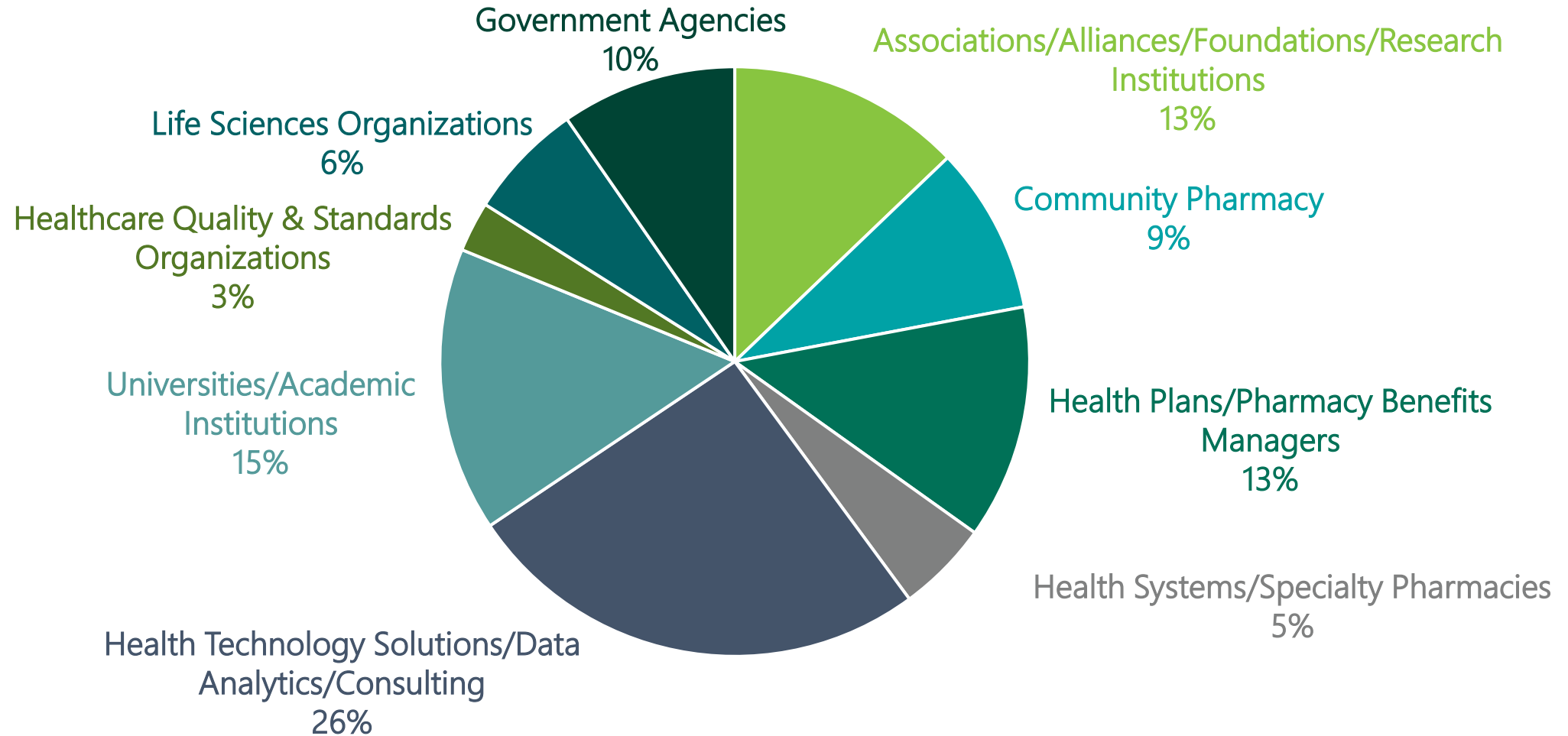

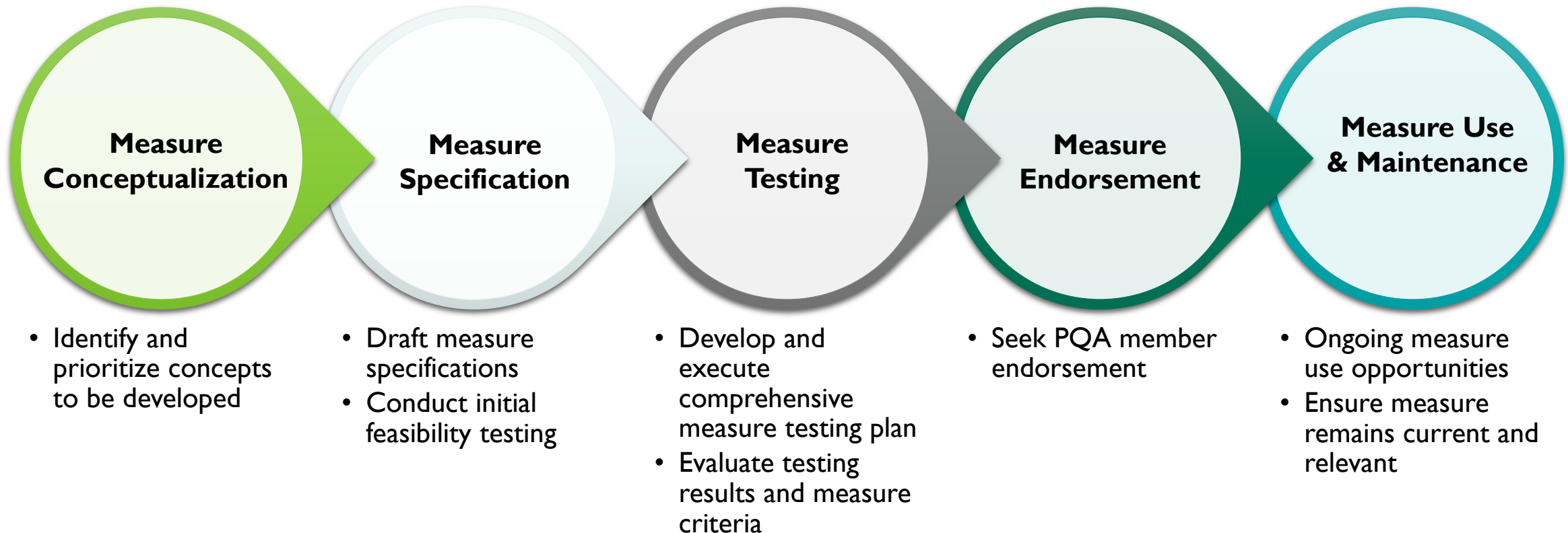

PQA Measure Domains

Adherence

- Diabetes
- Renin Angiotensin System Antagonists
- Statins

Appropriate Use

- Statin Use in Persons with Diabetes
- INR Monitoring for Individuals on Warfarin

Safety

- Polypharmacy in Older Adults
- Concurrent Use of Opioids and Benzodiazepines

Medication Management Services

- Completion Rate for Comprehensive Medication Review
- Medication Therapy Problem Resolution

INR = International Normalized Ratio

Health Plan vs Pharmacy Measures

	Health Plan Measures	Pharmacy Measures
Data Sources	Access to standard data sources	Limited access to standard data sources
Attribution	Attribution based on enrollment	Complex attribution model based on patient-pharmacy relationship
Intended Use	Standard measures and quality programs	Lack of standard measures and quality programs
Denominator	Larger target populations	Smaller denominators limit reliability *

* If the minimum denominator is not met, measure results do not distinguish true differences in performance and will not lead to sound conclusions about the quality of care provided

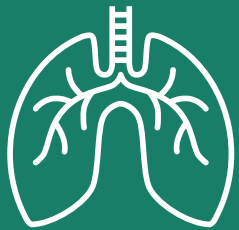

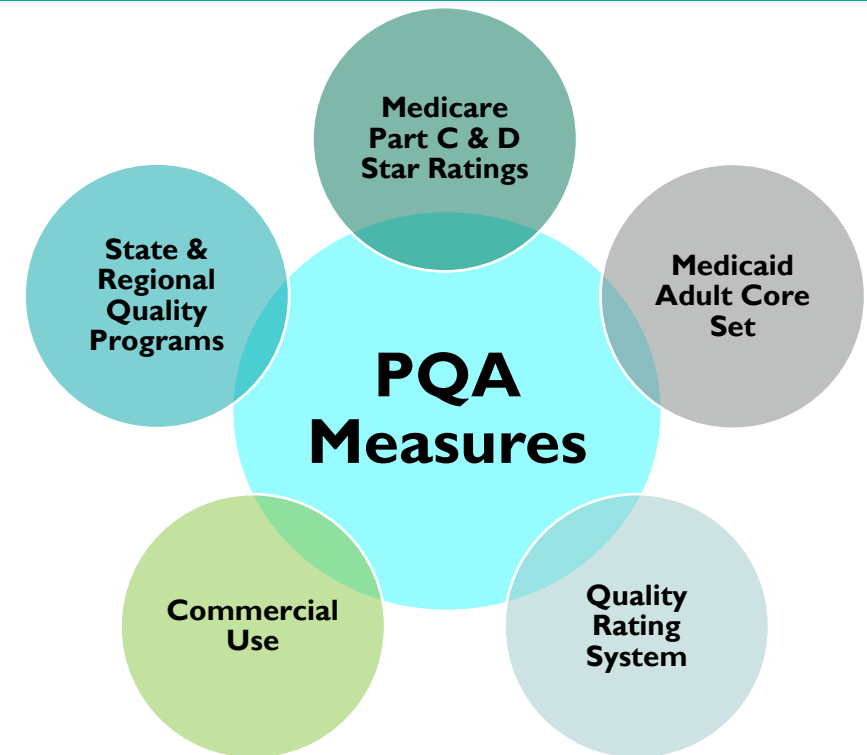

- For use in research: [Research License Request Form](#)

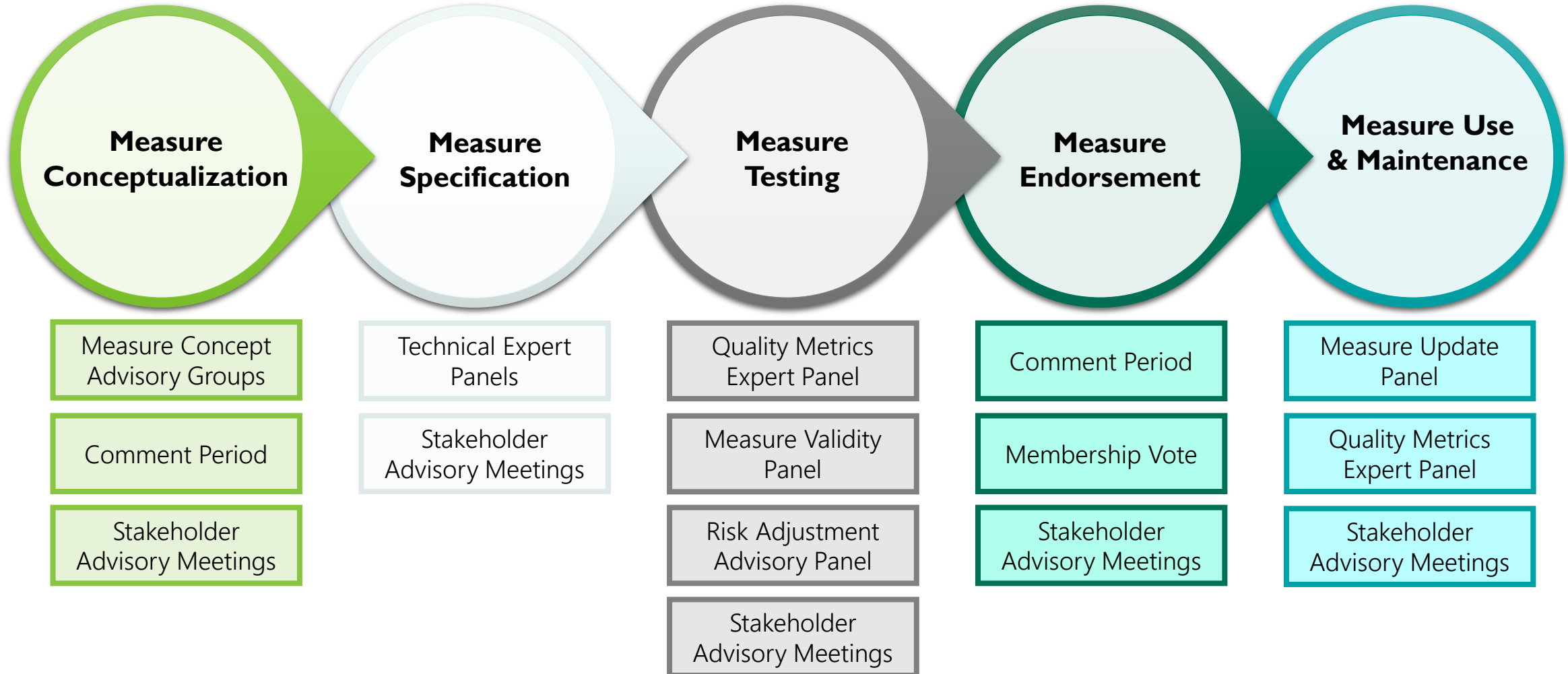
PQA Members Only

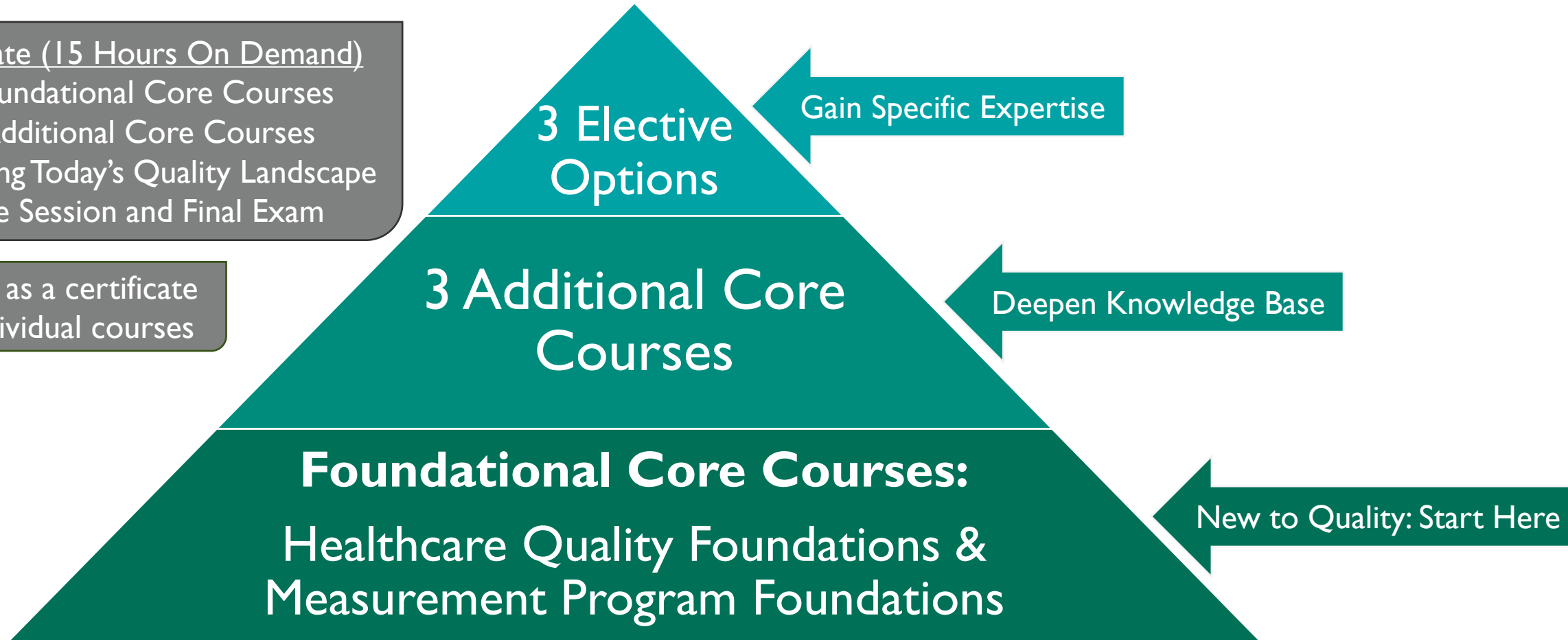

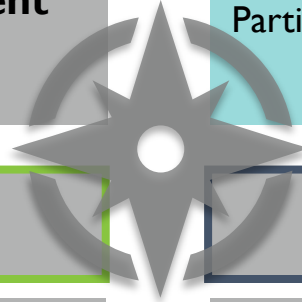

 - Examples:
 - Insulin persistence
 - COPD Treatment Ratio
 - Oral anticancer medication adherence or persistence*

Post-Measure Development

- Use and Impact Assessments
 - Examples:
 - CMR Experience Questionnaire
 - Specialty Pharmacy Turnaround Time
 - Insulin price cap impact on insulin persistence*

Non-Measure Quality Focused

- Patient Access and Experience
 - Examples:
 - Pharmacy Deserts*
 - SDOH Intervention Roadmap*
 - Medication Access Patient Journey
 - Patient Engagement Rubric

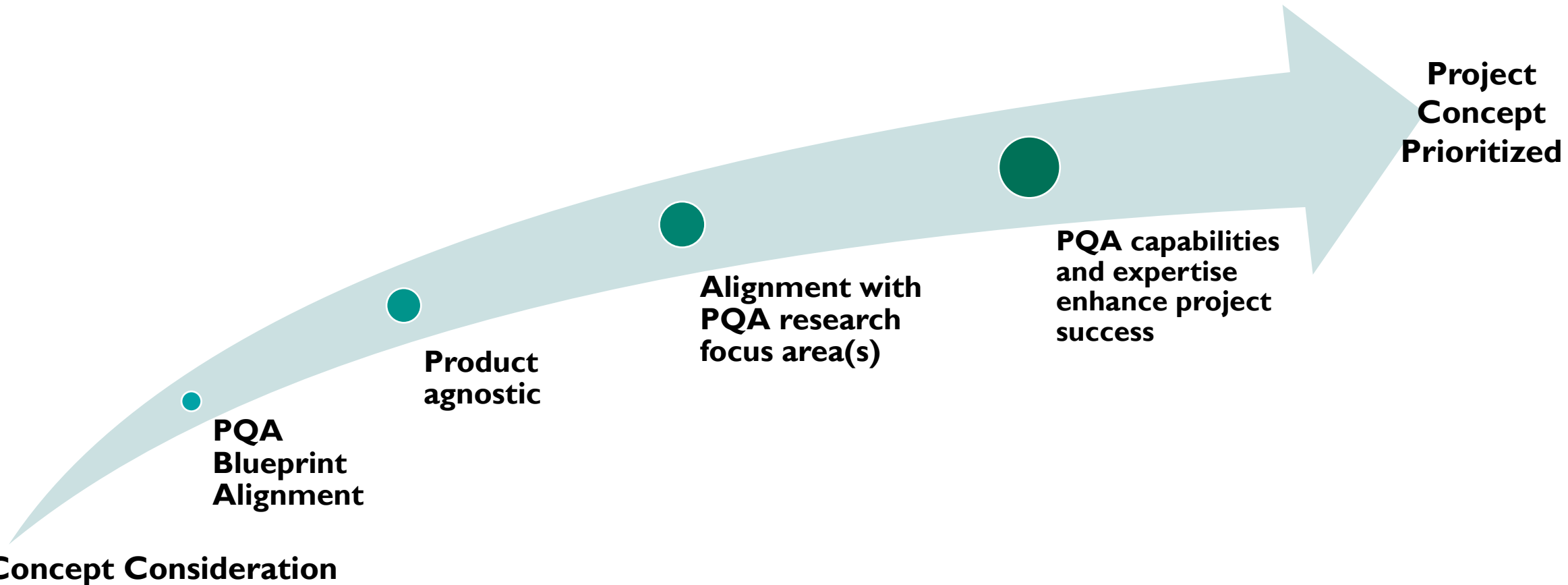

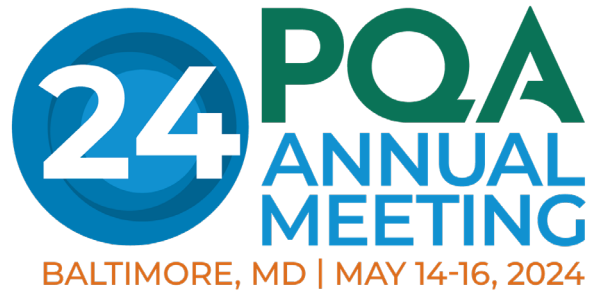
